## Fees and Terms of Payment for US and Canada

The fee for the exchange must be paid in full, in a single bank transfer,

## no later than 2 months before the start of the exchange.

Please contact your bank to temporarily increase the bank transfer limit, if necessary.

Please confirm with your bank that En Famille International is receiving the full amount requested, after transfer fees, if any.

Please note that all bank transfer fees (issuance fees, reception fees and exchange commissions) are at your expense.

- In the event of a one-way exchange, arranged as soon as there is a match

In addition to the price of the exchange, you will have to pay the sum of $\underline{\mathbf{2 5 0}} €$ per month to the foreign family that welcomes your child. This sum, which covers the costs of accommodation, food and leisure, is to be paid by bank transfer before the 1st of each month, or in a payment at the end of the stay, if the exchange is interrupted.

## - In the event of a two-way exchange, with unequal lengths

The amount to be paid to the foreign family will be prorated, based on the months passed (250 € per month not started)

## Here are some examples of situations which may occur:

- If your child has done their exchange abroad, but you do not receive the matched child in return (by decision of En Famille International, or by your choice)
- If you have not yet welcomed the foreign child, and your child must return before the end of their stay (by personal decision or disciplinary dismissal)


## - In case of early return/withdrawal

- In the case of non-departure of your child, regardless of the reason, $50 \%$ of the amount of the exchange will be retained by the Association. You will not be able to claim any reimbursement of the accommodation costs of the foreign child, or the application fee ( $120 €$ ), which remain with the Association.
- Once your child's exchange has begun, if you or your child decide to interrupt the exchange
- before the end of the first month, $75 \%$ of the exchange amount will be retained by the Association. Beyond the first month of exchange, $100 \%$ of the amount of the exchange will be entirely due to En Famille Internationa.
- In case of dismissal for disciplinary reasons, the total amount of the exchange will remain due to us even if the return takes place before the end of the first month.
- Tuition fees in the USA, Canada, UK

In some cases, there may be private school tuition, particularly in the U.S. If this is the case, we may ask you to share the cost of tuition with the foreign family, their part being up to $2500 €$.
